A MESSAGE FROM OUR COUNCIL PRESIDENT

ver the years I've had the opportunity to serve on more than one church council, the school board and some other boards for oversight etc. The one area that I become a little lost in has to do with accounting. As an example, I have been asked what happens to money that is given to the church for a particular cause such as supporting VBS, church camps, etc. Those types of questions aren't too hard and I say that the money is placed in that account when it is given and spent at the appropriate time based on direction from the church council or one of the persons designated to authorize expenditures from that account. If the expenditure is over \$500 it requires approval by the church council. These approvals most often take place at our monthly council meetings or by an e-mail request and approval by council members. If you give money for a particular item, it is pretty likely to be spent in the manner you have designated provided it is activity the council, on behalf of the congregation, is in approval. If the gift is for the general fund, the council pays the general bills out of this account as well as uses these moneys to pay for other things budgeted for. The council establishes a new budget each year and follows the budget to make sure we have enough money to operate the rest of the year. This seems to work.

Up until the last few years we were able to operate within the budget but did not have an excess of funds to deal with. As a result, the money was kept in our bank account with enough of a balance to keep us operating for the year. Since inception Living Word Lutheran Church has been fortunate to be the recipient of generous donations through its members and those visiting our church. In the past some of the donations have been in the form of a trust with a certain amount of the trust to be spent on various activities identified by the benefactor. This too seems to be working well.

The church has also been fortunate in receiving the grounds the church is located on as a gift, with most recently receiving additional grounds that are available when the church decides to additional building. Most recently Living Word Lutheran Church has been the recipient of a donation to be used for new construction or maintenance of our church facilities.

Where all of these gifts become a little fuzzy is not today or tomorrow but in a few years. By that time the church council has turned over at least one time and the original purpose of the gift has had been misplaced. Time to find out, but who do you ask? The funds have been invested and where are they?

The church council has recognized this situation and has appointed a board of three persons to oversee the expenditures, investment etc. of these gifts. It seems like most people know a person that is willing to invest money for us. We felt that the persons on this board should be made up of people that are familiar with safe investing and have been successful over the years with investing. We have asked Dave Hepper, Scott Maas and Paul Anderson to sit on this board to direct investments, track investments and direct spending. In addition to the three we would include the church treasurer to be a non-voting member of the board. This board will be able to track the progress of all the investments and trusts and be able to report on at least a semi-annual basis to the church council. Along with normal church financial activities, these accounts would also be subject to audit.

Thanks to the Lord and all that he does through you.

EVANGELISM CORNER

GREETINGS CHURCH FRIENDS!

s a first-year church council member serving on the evangelism and worship committee, I've been studying more about just what evangelism means. I hear the word often in church, read about it in articles and truthfully, have thought it to be defined as "preaching" or talking to people about God. What I didn't understand was a person doesn't have to be an "Evangelist" to practice "evangelism."

Pastor Melanie's sermon a couple weeks ago really brought this home to me. VBS had concluded that week and it was a total success with approximately 36 kids enrolled. She noted this and explained how everyone, young and old, is capable of performing acts of evangelism. This year's theme was "Shine Jesus' Light", and the kids were encouraged to shine that light daily just as Jesus did; by shining hope, love and forgiveness to everyone in their life.

As adults, we also need to remember this simple, evangelical objective, "Shine Jesus' Light." That can be achieved in everything we do and everywhere we are; work, community, family, etc. Every single person has gifts and abilities God blessed them with and when these talents are shared in acts people do, God is being glorified. The Christian gospel is being spread and that equals Evangelism! Jesus' light is shining through us, His children.

Yes, it takes wanting to serve, an active effort in finding ways to use your blessings from God and a committed purpose to creating a lifestyle centered around that but it is easier to achieve than people think. Did you know there are 5 P's of evangelism? Yes, and they are a guide to how a person brings evangelism alive.

PRIORITY – decide that evangelism is important and identify ways your talents can be used.
PRAY – ask God to place evangelical opportunities into your daily life allowing you to see and act upon.
PEOPLE – look around and identify people in need.
PROCLAIM – explain more than preach, of how acts of kindness, hope, forgiveness and joy performed make God come alive.

PERSEVERANCE – never give up! The world is a very big place and evangelism begins with ONE. ONE person, ONE act, ONE prayer, ONE connection and ONE success.

So, friends, I ask "How do you practice evangelism? How do you Shine Jesus' Light?"

DEAR FRIENDS OF ALWM INT'L,

Sally & I are stateside after a fruitful trip to Cambodia & Vietnam, our first time since 2019. Thank you for your prayers, as we continue to see people coming to Christ through our ministries in both countries! Lots of highlights to share in our next newsletter, due out late July. For now, here are a few photos, calls to prayer and calls to action. It's always about people and relationships, like part of our Vital Links team in Vietnam (below) & some emerging young leaders in Cambodia (1) Pictured right (2) are three young Muslim girls who were at the Preh Vihear Mission School dedication May 26, and will also be students when we open in August! Below (3) them is one of our Gospel House kids from Ho Chi Minh City!

This is my favorite photo (4) from the dedication, which had 200+ attending! Pastor Sam's Preh Vihear Church members stayed afterward to pray for the ministry of the new school in the lives of students and families in the months and years ahead. For more pictures, videos and info visit alwm.org/dedication.

Pigs for Pastors (5) is our new project in Laos, in partnership with Pastor Tom & Deuane Thorstad & Heart for Mission, our ALWM ministry there. Simple and creative way to make a life changing difference.

Cambodia Computer Lab Needed! (6). Local education leaders surprised Pastor Sam as they asked us to teach middle school students, thereby adding computer basics, English, Korean, and Chinese to our Bible teaching and full curriculum! So, we are asking the Lord to provide \$6000 for 12 Lenovo Thinkpads (left). Non-profits can buy them refurbished much cheaper here Sam can get a Lenovo fixed for free by a friend!

The young pastor of Khanh Hiep Church (7), in Vietnam's central highlands worships 200 weekly. There are four ethnic groups in the church, all reached witin the last generation, including the E-de people who are now 80% Chistian! They desperately need a water filtration system like (8) this because the well water is contaminated. For just \$975 we can install a system like the one here, giving clean water for church members and hundreds in the surrounding village for years to come! It's part of our Clean Water - Living Water Ministry.

Summer ministry in Belarus (Pastor Valery & his team) (9) and in Laos (Pastor Tom & Deuane Thorstad continues, with the Cambodia Youth Camp coming in August. We speak at LCMC Texas (July 28-29) and the NALC Convocation (Aug 8-11 in OKC).

Our operational income is still running about \$5000+ behind this same time in 2022. God is providing for life changing projects like the school, youth conference, water ministry and much more! We trust Him for operational support, so our expanding ministry to continue and to grow. We are currently revamping the website to reflect the growth and ministry of ALWM International! Thank you for your partnership in the Gospel in prayer and support! To God be the Glory!

LWLC JUNE 15, 2023, MISSION BOARD MEETING

MEMBERS PRESENT: Pastor Melanie Reiners, Linda Anderson, Gloria Cooley, Tim and Sue DeJong, Steve and Vicki Strege.

THE FOLLOWING TOPICS WERE DISCUSSED:

- It was reported that a total of \$5,039.49 was collected thus far this year for the **NOISY CHANGE OFFERING** with the offerings given to the following missions: January for Central Global Vision Fund Inc: \$2,660.99. February for Ukraine: \$726.99 via Samaritan's Purse. March for Turkey: \$443.25 via Samaritan's Purse. April for The Beacon Center \$179.56. May for The Alpha Center \$483.70.
- 2. JULIE SMUDE was contacted and informed the board that she was continuing in her mission work in Thailand. She is able to take a leave this summer and will be coming to speak at our church on July 16. LWLC will be providing her with hotel accommodations and we will take her out to lunch after the church service. She also expressed an interest in visiting with church members during the coffee hour. We will be setting out a basket to collect an offering for her mission work and we will continue to support her mission work with noisy change offerings as well as a line item on the benevolence section of the church budget. We need to be sure to make the congregation aware that she is coming and that we will be taking up a collection for her.
- We will follow our regular schedule of NOISY
 CHANGE OFFERINGS for the rest of the year as follows:
 June: Call to Freedom

July: Mercy Meals August: Fellowship of Christian Athletes September: The orphanage in Sierra Leone October: Mission work of Pastor Bill Moberly November: Operation Christmas Child December: (We will leave this open for now and if we have a new pastor by then we will be able to include his suggestion)

- **4. PASTOR BILL MOBERLY** will be coming to LWLC on Oct. 8 to share information about his mission work. We plan to have a mission festival type of service and meal that day to give Pastor Bill the opportunity to meet with the congregation. We also discussed the possibility of supporting members of our church who are interested in traveling with Pastor Bill to Vietnam in the spring and summer of 2024.
- 5. We discussed the possibility of supporting a speaker at MHS to talk about HUMAN TRAFFICKING. Sandy Christensen stopped by the meeting and said she would check into this matter.
- 6. It was reported that the \$5,000 that was taken out of the **MISSION BUDGET** to match the collection for Michael Sanchez in October was returned to the mission fund after the request to return it was made to the council at the June meeting thus making the total of the mission board at \$10,301.51 as of June 15, 2023.
- 7. The MISSION BOARD was also informed by the council that if they were giving \$500 or more in mission aid it must be approved by the council. This is just a balance and check process.
- 8. The mission board needs to prepare a set of guidelines for the operation and expenditures of the mission board that will be presented to the council for approval. They will be helpful to promote fair operations of the mission board. This is a work in progress now.
- **9.** The **NEXT MISSION BOARD MTG** is set for Aug. 3, 2023, at 1:30 PM the meeting was adjourned.

They will be screwed on to hold better. A chair lift will be purchased to make moving stacks of chairs around easier. They will look at getting Plunkets out to address the ant problem. Kelly made a motion, and it was seconded by Sandy to approve the property and management report. Motion carried.

WORSHIP & EVANGELISM: Sandy will try to include an "Evangelism Corner" in the monthly newsletter. Kelly made a motion and it was seconded by Steve to approve the worship and evangelism report. Motion carried.

YOUTH & EDUCATION: Included elsewhere **OLD BUSINESS:** The money was moved from the liquid CD to the investments on the broker CD as recommended by Dave Hepper and Scott Maas for the 12,18,24 and 48 month terms.

NEW BUSINESS: Cory Hooth spoke to the council about various safety scenarios and the importance of having a plan in place and to always be observant of our surroundings and anything out of place. Vicki Strege asked the council to have funds returned to the impact fund that should have been taken from the general (evangelism) fund for the Michael Sanchez fundraiser. Steve made a motion, and it was seconded by Marty. Motion carried. Pastor Swanson and his wife will be here the weekend of June 24 to visit the church and community. Details are being worked out. The call committee also interviewed another candidate over zoom the June13. Steve made a motion, and it was seconded by Dale to propose a position of business manager for the church. Motion carried. Detailed job descriptions will be written for office staff.

DATE OF THE NEXT MEETING: The next council meeting is scheduled for July 12 at 7 PM.

ADJOURNMENT: A motion was made by Kelly and seconded by Steve to adjourn the meeting. The meeting was closed with the Lord's prayer.
