
# **To All Women of Living Word**

f a member of the congregation was asked what the most important part of the church building is, a large majority would probably say the altar. In the Bible, the altar is a recurring theme, and one that has been used throughout history to signify a place of sacrifice, worship and reflextion. Our children are baptized and confirmed at the altar. God blessed marriages there and offers the promise of eternal life as funeral services take place at the altar. It is a sacred place where prayers are heard an experienced one. Our church calendar guides us through the year and it's seasons such as Advent, Lent and others. The color of the paraments on the altar and pulpit changes with each season along with some of the special days of the year such as Pentecost or All Saint's Day. Displaying the correct color is one of our duties.

Preparing communion on the first Sunday of the month and chapel communion on the second is our main task. Often that might be the only duty

and forgiveness is given. What a privilege it is for those in our church who care for this focal point!

As we come to the end of the church year, the ladies of the altar guild are asking other women of Living Word



for the month along with taking care of flowers given by members of the congregation. Setting up the Advent wreath, the Lenten cross, or table of candles as we remember those who have left our congregation or

We will be having a short meeting on Sunday, November 5 at 9:15 AM in the north end of the fellowship hall during the coffee hour. #### LWLC OCTOBER MISSION BOARD MEETING

Pastor Melanie opened the meeting with prayer for guidance as we deal with the various topics of discussion as well as for mercy, safety and protection for Israel at this time.

**MEMBERS PRESENT:** Gloria, Sue, Marcia, Linda, Pastor Melanie, Steve, and Vicki.

### THE FOLLOWING ISSUES WERE DISCUSSED

- Rolls for the FCA meetings have been paid for by LWLC. The cost of the rolls for the bimonthly meetings is around \$1,000 annually. It was decided that Pastor Melanie would offer the opportunity to other local churches to contribute to the annual cost of the FCA rolls at the next Milbank Ministerial Association meeting. Each church could choose the amount they wish to contribute and give it directly to FCA who would then take overpaying the monthly bill. Pastor will contact Brian Sandvig to talk about the account for FCA.
- 2. Pastor Melanie advised the board to include specific dollar amounts in the Annual LCMC Report to the congregation as well as letting them know what missions and causes were recipients of the funds.
- **3.** It was noted that since the activity and the projects of the mission board are continually increasing that it would be advisable to have a treasurer for the organization. Marcia Heinje volunteered to accept this position.

**4.** There was much discussion about the accounting process of funds given to missions and other areas. Pastor assured us that now that we have a permanent business manager that changes will be made so that we can easily see where and how the money is recorded.

- 5. There was a discussion about the term mission account and the LWLC Impact the World account. In the past they have been separate entities, however their functions seem to be intertwined. A motion was made by Sue and seconded by Gloria that all mission dollars are to be given to the impact the world account except for noisy change. Motion carried. It was also discussed that if there is a special mission project in mind it should be noted when the money is given. The office will send out a letter to the congregation explaining this change. It should be noted that noisy change has its own separate account for accounting purposes.
- **6.** Sue indicated that she and Tim have committed to go to Vietnam on a mission trip with Pastor Bill Moberly on May 29 through June 14. Vicki also indicated that she is considering going as well as she is an volunteer of ALWM. A fundraiser pancake breakfast is being planned for November 19.
- 7. It was decided to designate the noisy change in December to Jordan Hins and his mission work in Istanbul, Turkey. Jordan, who is originally from Milbank, is associated with Cru Ministries and has been sharing the love of Christ with the people in Turkey for several years.
- **8.** The next meeting is scheduled for November 16, 2023, at 2:00 PM.
- **9.** Steve made a motion seconded by Linda to adjourn the meeting. Meeting adjourned.

A clean up was done along with needed updates to the office computer. We will proceed with getting a new phone system. Moe made a motion, and it was seconded by Marty to approve the business manager's report. Motion carried.

**PASTOR'S REPORT:** Pastor asked if we could do communion 10/29 instead of 11/5. She will be gone from Nov. 2-12. David Kruger and Brian Sandvig will cover the pulpit supply needs the two Sundays she is gone. The mid-week advent series will start 11-29. The sunday school christmas program will be 12-10. Kelly made a motion to accept the pastor's report and it was seconded by Steve. Motion carried.

**PROPERTY & MANAGEMENT:** A better snow fence was purchased and installed. The "No Parking" signs were beefed up so they shouldn't blow over in strong winds anymore. Metal tags with installation dates were put on the new heat pumps. The new furnace filters will be put in once we have new property and management people, so they know how to do this. More cleaning was done in the dynamic disciples den. The front bushes will be trimmed. Steve made a motion, and it was seconded by Kelly to approve the property & management report. Motion carried.

**OLD BUSINESS:** Dave Wagner attended the LCMC conference. He reported that there are about 1,000 LCMC churches. There are many churches looking for pastors and others are struggling. Dave feels good about where Living Word is at this point. We are not struggling as others are. "God will let us know." The space needs committee has been established and is comprised of Dave Hepper, Brian & Janel Sandvig, Laurie Maas, Dale Prisinger, Steve & Vicki Strege and Gloria Cooley.

**NEW BUSINESS:** The council binders will need to be turned in at the November meeting. Kelly made a motion, and it was seconded by Sandy to approve the investigation of the economic development grant funding. Motion carried. We will look to the servant teams to supply a light supper for the Advent midweek services. A pancake and sausage meal will be served after the annual November 19 to raise funds for the mission trip. Sandy made a motion, and it was seconded by Dale to lease the new phone system. Dale Prisinger has agreed to be an advisor to the new property and management team. Guidelines will be established as to not abuse this agreement. A special budget meeting will be held October 25 at 7 PM. Rhonda made a motion, and it was seconded by Moe to move money from the general fund to the dedicated fund so the dedicated account will balance to the checking account. Motion carried. Rhonda made a motion, and it was seconded by Steve to move \$2,000 from the general fund to the dynamic disciples. Motion carried. A new radio broadcast expense account will be set up. Christmas Eve falls on Sunday this year. We will plan on having our regular 10 AM service and a 5 PM candlelight service.

**DATE OF THE NEXT MEETING:** The next council meeting is scheduled for November 15 at 7 PM.

**ADJOURNMENT:** A motion was made by Kelly and seconded by Sandy to adjourn the meeting. The meeting was closed with the Lord's prayer.
